### 7. 2WW Form

GF gave an update on the incorrect version of the LSESN 2WW form that has been circulated to some GPs in the London Cancer area without SASG approval. The Transforming Cancer Services team has said that it is not possible to re-circulate the correct form as it is already embedded on the GP systems in these CCGs however they have updated the form to be circulated to the remaining CCGs in London Cancer and also for rolling out to LCA. The form will be amended again following the publication of the new NICE guidelines and so will be re-circulated to all GPs

The SAG questioned why the form needs to be signed off now, and whether it would be better to wait until the publication of the NICE guidance. The SAG were also unhappy with the layout of the form. GF explained that the form does not look the same when displayed electronically, however the SAG felt that some GPs will print off the form and so it is not fit for purpose. The box for clinical history in particular was felt to be too small and not very clear.

AN will feedback comments to the TCS team.

### 8. Any Other Business

Item on next agenda – feedback of RMH study day and discussion of future educational meetings. JWo to contact Sarcoma UK re support/sponsorship of LSESN sarcoma diagnostic engagement event.

AN updated that NHS England (London) is being re-structured. There will be three area teams: SE and SW; NW; NC and NE. Each area will have nominated service specialists and supply managers. Regional Level service specialists will be appointed responsible for a Programme of Care (cancer). They will assume responsibility of pan London commissioning for sarcoma. Until they are in post AN will continue to attend the SAG.

MN noted that RNOH currently hold all surveillance patients (3-6 monthly MRIs for diagnostic uncertainty) on the PTL which has become more problematic now that it is a requirement to submit PTLs weekly. RMH, UCLH and NHSE agreed that such patients do not need to remain on the PTL; the clock can be stopped for these patients as surveillance counts as a treatment. Following this discussion RNOH will look at taking these patients off the PTL so that they are following the same policy as other SAG centres.
